The Franke General Guarantee

Our guarantee against manufacturing defects will apply, providing the product has been installed in accordance with Franke's installation instructions, the product has been used as recommended by Franke in normal domestic situations and a claim has been made in accordance with all applicable guarantee terms and conditions (including those set out below).

This guarantee does not cover damage caused by improper use, wilful or accidental damage, damage caused by negligence, normal wear and tear, scuffs or scratches, improper installation, improper storage, abnormal usage (including usage in extreme temperatures) or damage caused by improper maintenance or cleaning (including the use of unidentified chemicals or cleaners containing corrosive agents).
