### 7.1 Precautions for safe handling

Appropriate personal protective equipment: see Section 8. Always keep in containers made from the same material as the original one.

Never use pressure to empty; the container is not a pressure vessel. Always keep in the same material as the supply container. Good housekeeping standards and regular safe removal of waste materials will minimise risks of spontaneous combustion and other fire hazards. 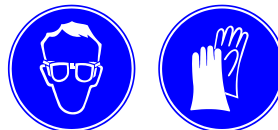
#### Appropriate engineering controls

All engineering control measures used to control exposure to hazardous substances must be selected, maintained, examined and tested to meet the requirements of the Control Of Substances Hazardous to Health regulations (COSHH). Similarly all personal protective equipment, including respiratory protective equipment, must be selected, issued and maintained to meet the requirements of COSHH.

These requirements include the provision of any necessary information, instruction and training with regard to their use. Special precautions should be taken during surface preparation of pre-1960's paint surfaces over wood and metal as they may contain harmful lead.

Provide adequate ventilation. Where reasonably practicable this should be achieved by the use of local exhaust ventilation and good general extraction. If these are not sufficient to maintain concentrations of solvent vapour below the relevant workplace exposure limits, suitable respiratory protection should be worn. (See personal protection below). Dry sanding, flame cutting and/ or welding of the dry paint film will give rise to dust and/ or hazardous fumes. Wet sanding should be used wherever possible.
