The responsibility of the Owner

The Purchaser is solely responsible for the use and application of any and all Eva-Last® Products, including but not limited to; determining suitability and compliance with applicable building and safety codes for a specific application. Eva-Last® Hong Kong LTD shall not be bound by any statement or representation as to the performance of Eva- Last® Product/s other than what is contained in this warranty. No person or entity is authorised by Eva-Last® Hong Kong LTD to make such statements or representations. This warranty shall not be amended or altered except in written form and signed by Eva-Last® Hong Kong LTD and the Purchaser. This warranty is exclusive and in lieu of any other warranties expressed or implied as to the merchantability, fitness for a particular purpose or non-infringement with respect to Eva-Last® products. In no case shall Eva- Last® Hong Kong LTD be liable for any incidental or consequential damages.

Eva-Last[®] Hong Kong LTD is not responsible for:

- the cost of labour for installing replacement products
- the transport costs of replacing any materials
- the cost of any materials (other than the replacement Eva-Last® Product/s as provided herein) including, without limitation, sub-structure, supporting structure, etc; or
- the cost of removing or disposing of Eva-Last® Product/s or other materials which are to be replaced. Replacement Eva-Last® Product/s will be warranted only for the remainder of the original Term. Tender of payment of the cost of replacement Eva-Last® Products shall terminate all liability of Eva-Last® Hong Kong LTD under this Limited Warranty and all applicable implied warranties.

What is the lifetime of Eva-Last® products?

It is natural for decking products to age. The process begins as soon as they are installed and exposed to the natural elements. The duration Eva-Last® Products will continue to perform for their intended purpose will depend on many factors, including, but not limited to the quality of installation, weather, snow, intensity of the sun, pollution, debris, usage, cleaning and care. Because no two installations experience these and other ageing factors in the same way, it is difficult to accurately predict the period of time Eva-Last® products will last. This Limited Warranty, subject to its terms and conditions, provides you with peace of mind and support in the event of a manufacturing defect which causes an Eva-Last® Product to fail. If Eva-Last® Products exhibit signs of failure, damage or degradation, such products should be replaced or repaired immediately, as this may become a safety hazard.

Notification of a claim

In submitting a claim, the Owner must fill out a Warranty Claim Form (available at www.eva-last.com) and submit his/her claim along with the signed warranty certificate, original purchase invoice noting purchase date, pictures of defective products and a detailed description, within thirty (30) days following discovery of a problem.

If the Owner fails to notify Eva-Last® Hong Kong LTD as provided herein, all obligations of Eva-Last® Hong Kong LTD under this Limited Warranty and all applicable implied warranties and conditions shall terminate. Notice to your contractor, dealer or home builder does not imply notice has been given to Eva-Last® Hong Kong LTD. Follow ups on claims can be directed to warranty@eva-last.com.

Right of inspection and claim processing

Eva-Last® Hong Kong LTD reserves the right to inspect the materials and investigate any and all claims that have been made. Eva-Last® Hong Kong LTD shall have a reasonable time after notification to process a claim. The Owner shall provide Eva-Last® Hong Kong LTD with reasonable access to the indicated Eva-Last® Product/s for purposes of inspection. If requested by Eva-Last® Hong Kong LTD, the Purchaser must complete and deliver the said product to Eva-Last® Hong Kong LTD at the Purchaser's expense. A warranty questionnaire, photographs of the defective Eva-Last® Product/s, proof of purchase of the Eva-Last® Product/s, and samples of the Eva-Last® Products should also be returned to Eva-Last® Hong Kong LTD as part of the claim items needed. If reasonable access is denied or made subject to unreasonable conditions by the Owner, or if the Owner fails or refuses to cooperate in Eva-Last®'s investigation of the claim (such as by failing to provide samples of the affected Eva-Last® Product/s, proof of Purchase, photographs, estimate, or a completed warranty questionnaire), Eva-Last®'s obligation under this Limited Warranty shall be immediately terminated. If Eva-Last® Hong Kong LTD determines there are manufacturing defects covered by this Limited Warranty, Eva-Last® Hong Kong LTD will have a reasonable time after receipt of notification to process the Owner's claim.

Transferability

This Limited Warranty may not be transferred

Eva-Last® InfinityTM deck boards are covered by a 5-year Stain Resistance Limited Warranty. Claims for Eva-Last® InfinityTM deck boards that become permanently stained from spills of food and beverage items including mustard, tomato sauce, barbeque sauce, canola oil, tea, coffee wine, fruit juice and carbonated soft drinks will be processed, provided the Owner has: promptly after the spill (approx. 10 minutes), attempted to clean the affected area of the boards by using the cleaning procedures described in the Eva-Last® Infinity™ Cleaning & Care Guide (available at www.eva-last.com); and if, after promptly cleaning a spill the stain remains unreasonably visible, the Owner must have the affected area cleaned by a professional deck cleaner at the Owner's expense within one week after the spill; and (3) if, after completing steps (1) and (2), the stain still remains unreasonably visible, the Owner must notify Eva-Last® within thirty (30) days after the professional cleaning is completed.

Eva-Last® Hong Kong LTD does not warrant Eva-Last® InfinityTM deck boards or any other Eva-Last® Product/s to be stain proof, and does not provide warranty coverage for food or beverages which are not properly and promptly cleaned as provided in the Eva-Last[®] Infinity[™] Cleaning & Care Guide or for any staining or damage to the Eva-Last® Infinity™ deck boards caused by abrasive compounds, mould, mildew, paints or stains, solvents, metallic rust, rust damage, rust stains or other non-food or non-beverage substances, including, but not limited to, biocides, fungicides, insect repellent, insecticides, plant foods or bactericides, motor oil and suntan/sunscreen lotions.

Exclusions from Limited Warranty coverage

5-year Stain Resistance Limited Warranty

Eva-Last® Hong Kong LTD does not warrant against and is not responsible for, and no implied warranty shall be deemed to cover, any product failure, product malfunction, or damages attributable to:

- Improper installation of Eva-Last® Product/s and/or failure to abide by Eva-Last®'s Installation Guidelines (available at www.eva-last.com), including but not limited to improper gapping.
 - Use of Eva-Last® Products beyond normal use, or in an application not recommended by the Eva-Last® Installation Guide and local building codes.
- Movement, distortion, collapse or settling of the ground or the supporting structure on which the Eva-Last® Product/s are installed. Damage to any building or supporting structure, either exterior or interior, or any property contained therein or for injuries or damages of
- any kind whatsoever. The cost of removal, reinstallation or disposal of any Eva-Last® Product/s, or for any costs associated with such, including labour, freight or taxes, unless otherwise stated in this Limited Warranty.
- Any Act of God (such as flooding, hurricane, earthquake, lightning, etc.), environmental conditions (such as air pollution, mould, mildew, etc.), or staining from foreign substances (such as dirt, grease, oil, etc.).
- Normal weathering due to exposure to sunlight, weather and atmosphere, which can cause coloured surfaces to, among other things, flake, chalk, or accumulate dirt or stains.
- Staining or discolouration due to foreign substances including, but not limited to food, beverages, dirt, oil, grease and chemicals found in cleaners not approved for use in the Eva-Last[®] Infinity[™] Cleaning & Care Guide.
- Variations in uniformity of colour, variations or natural changes in colour, weathering, colour fading and natural efflorescing. Heat damage caused by sources including, without imitation, fire and other enhanced or concentrated solar reflectivity or any other heat SOURCE
- Damage caused by improper handling, transport, storage, abuse or neglect of the Eva- Last® Product/s by the Purchaser, the transferee or third parties.
- Damage caused by factors that are beyond the reasonable control of Eva-Last®
- Any fasteners not supplied by Eva-Last®.

Under no circumstance will the Limited Warranty cover costs beyond the original purchase price of the defective Eva-Last® Product/s, as stated in the original purchase invoice.

Eva-Last® Product/s located in higher-traffic areas may show wear earlier than other areas. Dragging objects across the deck may cause surface scratches. Colour variation occurs naturally in the manufacturing process and, as with natural lumber, should be expected. Surface wear, scratches, minor degradation and colour variation are not defects and are excluded from coverage under this Limited Warranty. The serviceable life of the Eva-Last® Product/s is affected by several factors, such as quality of installation, maintenance and normal wear and tear. These are all factors beyond Eva-Last®'s control and for which Eva-Last® makes no warranty. No representative, employee or other agent of Eva-Last® Hong Kong LTD or any person other than Eva-Last®'s directors, has authority to assume for Eva-Last® any additional liability or responsibility in connection with the products except as described herein.

This Limited Warranty applies to Eva-Last® Products purchased on or after 1 September 2015 and supersedes all previously published warranties for such products. The terms and conditions of the Limited Warranty for Eva-Last® Products may change periodically. The Limited Warranty set forth above was the Limited Warranty offered by Eva-Last® at the date of printing.
