## Product Description

**NOPE!® Flea Killer Powder** is a ready to use insecticide powder for use against fleas, flies, (two winged), mosquitos, ants, cockroaches, wasps, earwigs, silverfish and other bristletails, bedbugs, dust mites, moths, booklice, aphids, caterpillars and sawflies. The product is for use on hard, porous and non-porous surfaces, hard and soft furnishings. For use indoors in domestic premises (including kitchens), can be used on pet bedding. For use outdoors in sheds, garages on paths, ant nests, wasp nests and refuse tips.

## Application Information

### Preparation

Apply a small amount of **NOPE!® Flea Killer Powder** to an inconspicuous test area of each substrate to be treated (e.g. carpet, sofa) before full treatment commences to ensure compatibility with the substrate.

Before treatment, clear as much floor space as you can to ensure that treatment is as thorough as possible.



Vacuum all areas prior to treatment. This has three advantages:

- Helps to remove any debris, eggs, larvae, pupae and adult fleas
- The vibration of the vacuum cleaner stimulates adults to hatch from their cocoon stage. **NOPE!® Flea Killer Powder** is most effective against adult fleas.
- Enables **NOPE!® Flea Killer Powder** to penetrate down to the base of the carpet fibres where fleas live.

After using your vacuum cleaner, always empty the contents into a black plastic bag. This will contain eggs, larvae and adult fleas and it is important to prevent any of these re-infesting the home. Therefore, immediately seal the bag and dispose of it in an outside bin.

Store away exposed foodstuffs and make sure you fully cover and seal any fish tanks. Remove any pets from the area.

### Application

Read the label before treatment. **NOPE!® Flea Killer Powder** is applied directly from the puffer bottle. Simply remove the lid, point the opening at the desired surface and give the bottle a gentle squeeze. Apply on hard, porous and non-porous surfaces at a rate of 10 g per m<sup>2</sup>. One bottle of 300 g of powder will cover 30 m<sup>2</sup>.

**NOPE!® Flea Killer Powder** has a residual effect for 24 – 72 hours. It is recommended that vacuuming be left until at least 3 days after application to allow maximum effectiveness. Reapply the powder after 3 – 5 days.

Wash hands thoroughly after use.

If **NOPE!® Flea Killer Powder** gets on to food contact surfaces, wash the surface thoroughly with soap and water before food is reintroduced.

## Flea Treatment Strategy

Treatment of carpets, floors, and soft furnishings with **NOPE!® Flea Killer Powder** forms part of a flea treatment strategy. Other suggested measures include:

- Application of veterinary approved flea products to your pet on a regular basis
- Brush out your pet's fur before going inside after walks, etc.
- Frequent vacuuming of the affected home, paying particular attention to the areas frequented by pets – especially carpeted areas, furniture that is used by pets, pet sleeping areas, etc.
- Regular washing of pet's bedding, blankets and other washable items in the hottest water possible
