Application Information

Preparation

Read the label before treatment. To ensure a successful application **NOPE!® Bug Bomb** should be used as part of a strategy to deal with the infestation.



Prior to the use of **NOPE!® Bug Bomb** thoroughly clean and vacuum the area to be treated. Bag up the waste and immediately dispose of it outside.

Before application, ensure that all people, animals, pets (including terrariums and aquariums) and food stuffs are removed from the area to be treated. All doors and windows must be firmly closed.

Application

One 250 ml aerosol will treat a space of 312.5 m³.

Then follow these steps:

1. Place **NOPE!® Bug Bomb** on a non-sensitive surface in the middle of the area to be treated.
2. Activate the aerosol by pressing down on the nozzle until it locks into position with a 'click'. The product will now start to dispense and completely empty.
3. Upon pressing the nozzle, immediately leave the premises and do not re-enter for at least 2 hours.
4. Upon re-entering the area, open all doors and windows to ventilate thoroughly, allowing between 1 hour to half a day of airing.

Other Information

Precautions: This material and its container must be disposed in a safe way. Do not touch treated surfaces until dry. Wash hands and exposed skin before meals and after use. Keep in a safe place. All bats are protected under the wildlife and countryside act 1981, before treating any structure used by bats, consult Natural England, Scottish, Natural Heritage or the Countryside Council for Wales. Do not contaminate foodstuffs, eating utensils or food contact surfaces. Cover all water storage tanks before application. Hazardous to bees. Exclude animals during application.
