This product contains crystalline silica (quartz sand). IARC has classified crystalline silica as a Group 1 carcinogen. Both IARC and NTP consider silica as a known human carcinogen. Because this product is in liquid or paste form, it does not pose a dust hazard; therefore, this classification is not relevant.
