### 5.3 Advice for firefighters

Promptly isolate the scene by removing all persons from the vicinity of the incident if there is a fire. No action shall be taken involving any personal risk or without suitable training. Fire will produce dense black smoke. Exposure to decomposition products may cause a health hazard. Cool closed containers exposed to fire with water. ### 7.1 Precautions for safe handling

Put on appropriate personal protective equipment (see Section 8). Eating, drinking and smoking should be prohibited in areas where this material is handled, stored and processed. Workers should wash hands and face before eating, drinking and smoking. Remove contaminated clothing and protective equipment before entering eating areas.

Never use pressure to empty; the container is not a pressure vessel. Always keep in the same material as the supply container. Good housekeeping standards and regular safe removal of waste materials will minimise risks of spontaneous combustion and other fire hazards. The Manual Handling Operations Regulations may apply to the handling of containers of this product. Packs with a volume content of 5 litres or more may be marked with a maximum gross weight. ### Recommended monitoring procedures

#### Appropriate engineering controls

Special precautions should be taken during surface preparation of pre-1960's paint surfaces over wood and metal as they may contain harmful lead.

Provide adequate ventilation. Where reasonably practicable this should be achieved by the use of local exhaust ventilation and good general extraction. If these are not sufficient to maintain concentrations of solvent vapour below the relevant workplace exposure limits, suitable respiratory protection should be worn. (See personal protection below).
